Cape Vintner Classification - Qualification for CVC membership is based on meeting a set of criteria including: Estate ownership and independent audit and evaluation of: Technical and Environmental standards, Cellar Door facilities, Ethical matters and Wine quality.



GLOBALG.A.P. - An internationally recognised set of farm standards dedicated to Good Agricultural Practices (GAP). Through certification, producers demonstrate their adherence to GLOBALG.A.P. standards.



Green Mountain Eco Route - The express purpose of this Route is to nurture the natural environment, while at the same time, allowing for the social upliftment and sustainable development of the resident communities and businesses, and the cultivation of eco-tourism.



South African National Halaal Authority - The Wildekrans Olive Oils are SANHA approved. SANHA is a representative authority, which promotes professionalism and excellence in the certification of Halaal food and other related products.

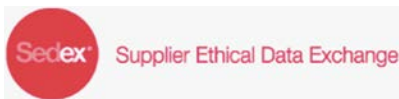
The Old Vine Project - An initiative dedicated to preserving vineyards 35 years and older, through trade initiatives and sustainable projects.



Sustainability Initiative of South Africa - Assists growers with ethical labour and environmental practice compliance. SIZA is a South African standard; developed, owned and operated in South Africa - and is aligned to global best practices.



Sustainable Wine South Africa - An the alliance between the Wine and Spirit Board (WSB), the Integrated Production of Wine (IPW) scheme and Wines of South Africa (WOSA). Together these organisations are driving the South African wine industry's commitment to sustainable, eco-friendly production. A certification seal appears on each container of wine which has been certified by the Wine and Spirit Board. This seal is a guarantee of origin, vintage and variety as stated on the wine label.



Supplier Ethical Data Exchange - A membership organization dedicated to driving improvements in ethical and responsible business practices in global supply chains.



Wine & Agricultural Ethical Trade Association - An organisation which actively promotes ethical trade in the wine industry value chain through training, technical assessment and audits to assess members' compliance with its code of good practice.

World Wildlife Fund - South African Biodiversity & Wine Initiative (Champion Status) - A voluntary membership model, where landowners commit to biodiversity-friendly farming practices, conserve their natural areas and continually improve their water and energy efficiencies. Champion status is awarded to only a few exemplary wine producers, with at least 10% of their farm committed to conservation, whilst implementing environmentally responsible management practices both within their cellars and on the farm. In addition, these producers or growers have fulfilled the stringent BWI Member criteria, established and audited by the BWI committee.

Nedbank Green Wine Awards Overall Category Winner: Best Farming Practices (2015 & 2017)

And Overall Category Winner: Social Development (2015) - These awards, key accolades in the Nedbank Green Awards stable recognises sustainable farming, fair labour practices and conservation of the Cape winelands. Key criteria for this award include the wellbeing of farm employees and surrounding communities, and the wider impact of farming on the surrounding environments.



Department of Agriculture Winner: Best Farm of The Year Award (2015 & 2016) - This competition aims to celebrate excellence among those working in the Province's agricultural industry, across 11 categories and in 16 districts.



Novare Trophy for SA Terroir Top Wine Estate (2012) - The Novare South African Terroir Wine Awards honours the wines and wine estates which truly portray South Africa's different wine growing areas.
